INTRODUCTION

All academies within the trust have their own specific Safeguarding Policy which is reviewed and updated (when required) annually by the Local Support Board, in order to protect and safeguard their students.

In addition to their own policy, academies in the trust adhere to the following overarching Safeguarding Policies and Procedures:

- All new staff recruited in line with the SCR (Single Central Record) and Vetting Policy.
- All academies have a Designated Safeguarding Lead (DSL), and a Deputy DSL who have completed Safeguarding Lead training.
- All new staff receive a site and safeguarding induction during their first week of employment, which includes training on the academy's safeguarding policy and procedures, carried out by the DSL.
- All staff complete annual Safeguarding and Prevent training as a minimum.
- All academies have a named Designated LAC (Looked After Child) Teacher.

Section 175 of the Education Act 2002 requires academy governing bodies, local education authorities and further education institutions to make arrangements to safeguard and promote the welfare of all children who are pupils at an academy, or who are pupils under 18 years of age. Such arrangements will have to have regard to any guidance issued by the Secretary of State.
